- ☐ Equipped with (Dedicated fleet of trucks to ensure faster movement of the material from the premise)







CORE PHILOSOPHY



At OLSC, we pride ourselves on our dedication to social responsibility, both within our organization and in the communities we serve. This ensures that the driver returns to his family every 24-36 hours. Drivers who return to family frequently do not get involved in malpractices and take care of their own families.
- **(C) Livelihood**: We provide residential and mess facilities to our employees, labours and drivers in all our nationwide facilities, ensuring they have access to good living conditions.











2. Training:

- (A) Employee Training: Our training center, Om Institute, Jamalpur, provides hands-on training and in-depth knowledge about logistics and supply chain management. This ensures that all employees, regardless of their role, stay updated with industry standards and advancements.
- **(C) Driver Training:** We provide regular training to our truck pilots to ensure their safety and the goods they transport. This training covers focused driving, maintaining optimal speed, enhancing fuel efficiency and taking regular breaks as needed.
- (B) National Skill Development Corporation: Om Logistics is a proud partner of the NSDC Program. Through this partnership, we aim to promote skill development to all by offering training in vocational courses, technical skills and industry knowledge. After training, candidates have the opportunity to join us for various job roles or can explore opportunities with other organizations.

3. Green Initiatives: Carbon Footprint Reduction

- **(A) Tree Plantation:** We believe in giving back to nature and actively participate in plantation drives on our facilities and apart areas, contributing to environmental sustainability.
- **(B) Solar Energy:** We operates our various nationwide warehouses and other facilities using solar generated energy.
- **(C) Yamuna Cleanliness Initiatives:** Our employees are involved in removing plastic waste from the Yamuna River, promoting environmental health.
- **(D) Electricity Consumption:** To reduce our carbon footprint and electricity consumption, we have implemented transparent roof sheets for natural lighting and turbo ventilators for improved air circulation.
- **(E) Societal Welfare Contributions:** We prioritize the safety of our community by providing various aids, grants, donations, as well as food and medical supplies during natural calamities.



4. Pandemic Support

During the pandemic, we transformed our warehouses into medical facilities by installing beds and oxygen cylinders. We also provided testing for all our workforce and their families and distributed oxygen concentrators for free.

Along with providing medical aids, our supply chain network has set a benchmark by delivering essential medical supplies nationwide during the lockdown and supporting NGOs with their logistics needs.




